END OF PAYROLL YEAR

Our end of financial year is rapidly approaching. If you need assistance with creating your Payment Summaries and turning over your financial year, please contact me as soon as possible. Just let me know the date of your last pay. We will need to complete the turnover procedures prior to your next pay day. Note tax tables are available for all current MYOB payroll products. I am travelling overseas in July for about 6 weeks. My last available day is 9th July.

SUPER STREAM

SuperStream is the process of standardising how employers make their superannuation contributions. Essentially, as of July 1 2016, no employers could directly pay their employee's super to the employee's nominated super fund. A Third party now needs to perform that function.

MYOB is one of the authorised agencies that can make these payments on your behalf. It does not matter whether you are using the Classic Platform of v19, AccountRight Live v2016 or AccountEdge.

What is even nicer is that there is no additional cost to you. Your current monthly or annual subscription covers the cost of this service. The initial process of getting it started is a little time consuming, but after that the payment of your super will become very simple and efficient. Give me a call and I can get you started on this prior to the need for your first payment in 2016/17 financial year.

MOVING TO AccountRight

If you are currently paying a monthly or annual subscription, and are using v19 you are entitled to upgrade to AccountRight v2016 at no extra cost. I have been using this platform for about four years now and am very happy with its performance and features. I particularly like the link to my bank account that means that I can download all of my transactions directly to MYOB. TRAINING COURSES
